## Parking

How good are your, and your guests', parking skills? We have

received several complaints about neighbors and guests who have been towed because they are parked too far away from the curb. The Parking Guidelines are listed in the Homeowner Re-Sale Package (House Rules), on our website, and almost quarterly in our newsletter to the community.



How far should people be allowed to parallel park from the curb? The Virginia DMV allows 12 inches, and our community allows approximately 24 inches. Any further than that and the vehicle starts to impede traffic. Our guidelines to our tow company, Dominion, are to tow from our No Parking zones, indicated by a yellow curb, and for not having two tires on the concrete curbing. Dominion will take photographs of violations prior to towing.

All Park West Community Association (PWCA) residents will receive an application for pool passes from our management company, Koger Management. Residents interested in obtaining a 2005 pool pass should complete the application and return it to Koger. Residents in good standing with the PWCA (no delinquent dues, no 2<sup>nd</sup> or 3<sup>rd</sup> ACC or trash violations) will receive their pool passes in the mail prior to the opening of the 2005 pool season.

The pool is for your use and enjoyment. PWCA residents interested in using the pool for birthday parties or small gatherings should contact the pool chair in advance of the intended day to reserve the use of the pool. Our annual 4th of July pool party will be

held on Monday, July 4th, and details will be forthcoming. It is our hope that this upcoming swim season will be one of fun and enjoyment for all.

#### **Important Community Reminders Exterior Improvements**



If you're planning any changes or improvements to your home - including storm doors, windows, painting, deck, fence and shed improvements, or landscaping – you need approval from the Architectural and Control

Committee (ACC). See the PWCA website (www.parkwestcommunity.org, Rules & Regulations and Community Information), or email the ACC chair at acc@parkwestcommunity.org for more information.

#### **Trash Policy**

Trash is collected on Tuesday (including recycling) and Friday mornings. Trash can be put on



pick-up corners only in black heavy duty trash bags or in covered trash cans after 6 pm the night before pickup. White trash bags and grocery bags are not allowed. Cans and recycling bins must be removed from public areas the same evening after collection. Cans and bins left in common areas will be collected and taken to the pool for storage. Residents can re-claim their bins and cans at the pool. Violations will result in fines of up to \$50.
