**Alcohol:** Underage drinking, drinking and driving, and drinking in public are against the law and will not be tolerated. Know the law. Neighbors are observant, and diligent about calling the police when alcohol is involved.

**Noise:** County noise ordinances will be strictly enforced. Keep guests, and noise, inside to avoid a visit from the Fairfax County Police Department. Multiple calls to the police could jeopardize your ability to reside in the community.

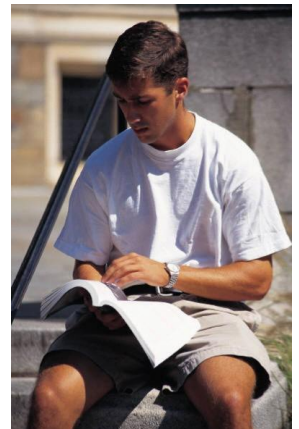
**Parties:** You are responsible for your conduct, and that of your guests. Be sure they know the rules about noise, parking, and alcohol. If they leave a mess, *it is your responsibility to clean it up to avoid fines for trash.*

**Parking:** Each home in Kings Park West is assigned two parking places. Do not park in neighbors' spaces at any time. Guests must park in designated parking areas. Towing is strictly enforced. Claiming your towed vehicle will put a dent in your spending money for the month.

**Trash:** You are responsible for keeping the property you are renting clean, and properly disposing of trash. You are also responsible for cleaning up after your visitors if they leave trash on the Kings Park West property.

### **Trash Disposal:**

- Trash is collected Tuesdays and Fridays; recycling on Tuesdays.
- Do not put trash out before 6 pm the night before pick-up.
- Trash can only be put out in Trash cans or dark, heavy-duty trash bags. *Under no circumstances* may white trash bags be used.
- Garbage cans must be reclaimed by 6 pm on pick-up day or they will be collected.



**Fines:** Violating the rules will cost you. Fines are issued to the property owner, who will pass them on to you directly, or take them out of your security deposit.

# Fairfax County Noise Ordinance

## CHAPTER 108.1 (NOISE ORDINANCE)

### ARTICLE 4 Prohibited Sounds.

#### Section 108.1-4-1.

(j) Unless otherwise excepted by this Chapter, any person, motor vehicle or instrument that permits, operates, or causes any source of sound or sound generation to create a sound that is plainly audible in any other person's residential dwelling with the doors and windows closed:

(1) Between 10 p.m. and 7 a.m. on Sunday through Thursday, or between 11 p.m. and 7 a.m. on Fridays, Saturdays, and the day before a Federal holiday; or

In addition, the source of sound or sound generation must be discernible regardless of whether such doors and windows are closed.

(k) Any owner or person in control of any animal that allows or otherwise permits any such animal to bark, howl, bay, meow, squawk, quack, crow or make such other sound:

(1) Between 10 p.m. and 7 a.m. that is plainly audible in any other person's residential dwelling with doors and windows closed and the source of sound generation shall be discernible regardless of whether such doors or windows are closed; or

(2) Between 7 a.m. and 10 p.m. when the animal sound is plainly audible and discernible across real property boundaries or through partitions common to residential dwellings and such sound can be heard for more than five (5) consecutive or non-consecutive minutes in any ten (10) minute period of time. Animal sounds that can be heard for less than five (5) consecutive or non-consecutive minutes in any ten (10) minute period shall not be subject to this Chapter.

## Minors Alcohol and Virginia Law

### DID YOU KNOW?

Alcohol is the most frequently abused drug. A minor is anyone under 21 years old with respect to beer, wine or liquor.

### IT IS A CRIME IN VIRGINIA FOR...

- Minors to purchase or possess alcoholic beverages.
- Parents or other adults to contribute to the delinquency of a minor in connection with the purchase or use of alcoholic beverages.
- Anyone to purchase alcoholic beverages for minors.
- Anyone to sell alcoholic beverages to minors.
- Anyone to drink alcoholic beverages in a public place (i.e., street or parking lot).
- Anyone to sell alcoholic beverages without a license to minors or adults, in a home or any other unlicensed place.
- Anyone to possess a false identification card or birth certificate.
- Anyone to operate a motor vehicle while under the influence of alcohol or a self-administered drug.

### THE PENALTIES CAN BE...

A fine up to \$1,000. - A jail sentence of up to one year - A required bond of up to \$1,000.

### WHAT'S MORE...

- If personal injury, property damage or death occurs as a result of the illegal use of alcohol by minors, parents and other adults involved could face a costly court action.
- The cost and availability of automobile liability insurance also may be affected by alcohol-related negligence or misconduct.
