PWCA PARKING PROGRAM MEETING

As promised in February, the PWCA HOA Board will hold a special community meeting on **Wednesday**, **3 October**, at **7:30pm** in **Robinson HS's Blue Cafeteria** to review the progress of the PWCA Permit Parking Program over the



past several months, and to discuss any outstanding issues and suggestions. The Parking Committee will have data relating to the program for review and discussion. PWCA R&Rs (REQUESTS AND REMINDERS)

- For community crime prevention and security, consider leaving your porch light on at night. A CFL bulb will minimize the cost of electricity and last years longer than an incandescent lightbulb.
- Recycling is Tuesday only, visible recyclables will be left curbside on Friday to litter our areas.
- Garbage and recyclables must be appropriately secured to prevent critter infestation or wind blown items; use cans or black bags only for garbage, bins or clear plastic bags (in bins) for recyclables.
- All resident's vehicles MUST have a parking permit; guests must have a temp or guest pass.
- Parallel parking--both wheels must be on the concrete apron (within 12 inches) of the unpainted curb. Dominion Towing: (703) 339-2400; impound location: 2810 Juniper Street, Fairfax.

APPROVED FOR THE RECYCLE BIN

- 1 Rinsed Aluminum Cans, Foil, and Trays
- 2 Rinsed Metal food & beverage cans
- 3 **Rigid plastics**
- 4 All rinsed glass food and beverage containers
- 5 All rinsed plastic containers labeled #1-7
- 6 **Rinsed Wide-mouthed plastic containers:** like buckets
- 7 **Non-hazardous aerosol cans:** like cooking spray, shaving cream, & cleaning sprays.



- 8 **All mixed paper:** This includes white and colored printer paper with or without ink, construction paper, window envelopes, or any type of paper insert
- 9 All paperboard products: This includes cereal boxes, frozen dinner boxes, cracker boxes, orange juice containers, chicken stock containers, or juice boxes.
- **10 Corrugated cardboard & pizza boxes**: Pizza boxes are safe to recycle as long as no grease has seeped onto the bottom of the box. Nowadays, pizza makers place a sheet of wax paper on the bottom of the box to protect the recyclable material. If grease is does manage to contaminate the box, rip the top of the box off and recycle. The top is still good to recyclable.

Requests should be made via the Architectural Control Modification Form found on the PWCA website. The completed form should be mailed to PWCA Architectural Control Committee, Attn: ACC Chair, c/o Capitol Property Management, 3914 Centreville Road, Suite 300, Chantilly, Virginia 20151. Chocolate Cake Cookies



Ingredients

- 1 package (18-1/4 ounces) chocolate fudge cake mix
- 2 packages (3.9 ounces each) instant
- chocolate fudge pudding mix
- 1-1/2 cups mayonnaise
- 2 cups (12 ounces) semisweet chocolate chips
- 1/2 cup chopped walnuts

Prep: 30 min. Bake: 10 min./batch Yield: 84 Servings

Directions

In a large bowl, combine cake mix, pudding mixes and mayonnaise; mix well. Stir in chocolate chips and walnuts.

Shape by teaspoonfuls into balls; place on greased baking sheets. Bake at 350° for 9-10 minutes or until cookies puff and surface cracks slightly. Cool for 5 minutes before removing from pans to wire racks. **Yield:** 7 dozen.

Cinnamon Chip Scones



Prep: 25 min. Bake: 10 min. Yield: 12 Servings

Directions

In a large bowl, combine the flour, 1/3 cup sugar, baking powder, baking soda and salt. Cut in butter until mixture

resembles coarse crumbs. Stir in buttermilk just until moistened. Fold in chips.

Turn onto a lightly floured surface; knead gently 10-12 times or until dough is no longer sticky. Divide in half; gently pat or roll each

Ingredients

- 3-1/4 cups all-purpose flour
- 1/3 cup plus 2 tablespoons sugar, divided
- 2-1/2 teaspoons baking powder
- 1/2 teaspoon baking soda
- 1/2 teaspoon salt
- 3/4 cup cold butter, cubed
- 1 cup buttermilk
- 1 package (10 ounces) cinnamon baking chips
- 2 tablespoons butter, melted


portion into a 7-in. circle. Brush with butter and sprinkle with remaining sugar.

ENERGY EFFICIENCY AND YOUR ATTIC

Did you know more than 100 million U.S. homes are under-insulated? That translates into billions of wasted dollars per year. Also, an under insulated attic can translate into an uncomfortable upstairs all-year-round. So, a resident took action and he could not be happier. In the summer, attic temperatures can rise to over 150 degrees overheating the upstairs bedrooms; also, conditioned air travels through heated attic spaces, greatly increasing AC energy costs and taxing the HVAC system.

The resident added a radiant barrier, (also called reflective insulation) in his attic to improve the comfort of his home and reduce his energy bills. An option he chose was the Green Zone; a multi-layer, thermal and reflective insulation that combines two layers of 99% pure reinforced reflective insulation with a center core of high-density encapsulated fiberglass that produces a



system R-Value of 11.6. The Green Zone works by deflecting heat away in the summer and reflecting heat back into the house during the winter. Traditional mass insulation only slows down heat transfer but the Green Zone combines an R-Value with a dualreflective shield that redirects 97% of the heat that it comes into contact with.

When correctly/professionally installed, the Green Zone is warrantied for the life of your home without settling, condensation, or mildew and is guaranteed to reduce energy costs by 25%. It never needs replacing or maintenance. It is free from dangerous fibers, off-gassing, or asthma causing allergens and it qualifies for the Energy Tax Credit. Other radiant barrier options can be found at your local Home Improvement Center.

Finally, our resident insulated the attic access hatch. The hatch leading to the attic can be a major source of energy loss equal to that of an open chimney flue. He installed weather-stripping to prevent excessive heat / cold transfer and an R-30 patch of reflective insulation to the wooden hatch. Attic hatch insulation kits can also be found at your local Home Improvement Center. So, with a little effort our resident is now much more comfortable upstairs, added resale value to the home, and the energy savings will soon pay for the upfront cost.
