Graduation Season Comes in June

Live or work near George Mason University? Keep track of this high school graduation schedule to plan your drives in and around the Fairfax campus.

About 25 different local area High Schools will have their commencement ceremonies at GMU's Patriot Center. While the Schedules is TBD you can expect the first 3 weeks of June to be the target dates. About 3,000 to 5,500 people attend each high school graduation hosted at the Patriot Center. Expect heavy traffic and possible delays on Braddock, Route 123, University Drive, Roberts Road and other connector routes on these days. Traffic will start slowing down about an hour before and after each two-hour ceremony.

PWCA Architectural Modifications

Exterior alteration or modification of a Kings Park West Community townhome (including window replacement) is not permitted without prior written approval from the Architectural Control Committee (ACC). Requests should be made via the Architectural Control Modification Form found on the PWCA website. The completed form should be mailed to PWCA Architectural Control Committee, Attn: ACC Chair, c/o Capitol Property Management, 3914 Centreville Road, Suite 300, Chantilly, Virginia 20151. Approval or disapproval will occur within sixty (60) days of submission of written request. Questions should be e-mailed to acc@parkwestcommunity.org.

FLAG ETIQUETTE

Ideally, an American flag on your house should hang from a staff that angles out from the front wall, a windowsill, or balcony. It's a good idea to screw a bracket made for holding a flagstaff to the trim. Fasten it securely so it won't become soiled or damaged. Do not allow the flag to touch the ground, floor, water, or anything else beneath it. It's also appropriate to hang the flag from a horizontal staff.

Whether the flag hangs from an angled or horizontal staff, be sure the union or canton (the rectangle with the stars) is at the peak. (Hanging the flag with the union down signals extreme distress.)

When the flag is displayed either horizontally or vertically against a wall, the union should be at the top and to your left. When displayed in a window, the flag should be hung so that the union is on the left when you see it from the street.

The American flag is meant to be a flag; don't use it for any other purpose. For example, don't use it as drapery, ceiling decoration, or as a bed spread. And never use it as a receptacle for carrying or holding anything.

Though it is customary to fly the flag from sunrise to sunset, the U.S. Code says that "when a patriotic effect is desired," you can display it around the clock. If you do, you should illuminate it with a light.

When displayed from a car, the flagstaff should be fixed or clamped firmly to the vehicle, ideally on the right side. The flag should not be draped over the hood, top, sides, or back. The same holds true for a flag displayed on a float in a parade. Don't carry the flag flat or horizontally. And, because it is not meant to be apparel, do not wear a United States flag. If you wear a lapel flag, pin it on the left side, near your heart.

Appropriate USA flag folding procedure: Basically, fold the flag in half width-wise twice. Fold up a triangle, starting at the striped end ... and repeat ... until only the end of the union is exposed. Then fold down the square into a triangle and tuck inside the folds.

Why bother with flag etiquette when you're excited about flying the Stars and Stripes? Consider this - for more than two hundred years, our country's military, firemen, police, and other service personnel have practiced these measures faithfully, treating our flag with the highest esteem. This is one way we can show respect and meet the high standard they have set.

2012 National Research

How satisfied are residents in homeowners associations with their elected boards? How do they feel about their association's rules and restrictions? How about their association assessments?

The Foundation for Community Association Research commissioned a national survey of association residents to answer these and other questions. Here are some of the key findings:

- Estimated number of U.S. association-governed communities and individual housing units and residents within those communities: 63.4 million
- 70 percent of residents in common-interest communities say they are satisfied with their community association experience, while 8 percent express dissatisfaction and 22 percent are neutral on the question.
- 88 percent of residents believe their association board members strive to serve the best interests of the community, while 12 percent say the opposite or aren't sure.
- 73 percent of residents say their professional managers provide value to their communities, while 21 percent of residents say the opposite is true and 6 percent say they aren't sure.
- 76 percent of residents believe their own community association rules "protect and enhance" property values. Only 3 percent say the rules harm property values, while the rest see no difference.
- 81 percent of residents say they get a "good" or "great" return for their association assessments, while 18 percent say the return is "not so good or bad." The reminder

The Benefits of Recycling Add Up!

- Using one ton of post-consumer paper to make new paper products saves approximately 7,000 gallons of water and conserves 3.3 cubic yards of landfill space
- Recycling 300 lbs. of paper saves roughly one tree
- For every ton of glass that is recycled we eliminate 384 lbs. of mining waste
- Using post-consumer aluminum cans to make new cans produces about 95% less air pollution as compared to the process of manufacturing aluminum cans from virgin materials
- Paper recycling reduces pollution by about 50%
- Recycling a 36-in stack of newspaper saves about 73 kilowatt hours of electricity (about 14% of a typical residential electric utility bill)
- Recycling one pound of aluminum saves enough energy to light a 100-watt built for 290 hours.
- It takes 64% less energy to make paper products from post-consumer paper, saving the equivalent of three barrels of oil for each ton of paper that is recycled

Saturday, May 25th, Atlantic Pool Services will open our PWCA pool for the start of the 2013 summer season. Pool pass applications have been mailed out in March along with the quarterly invoices. Residents should complete and return the application to Capitol Property Management by April 30th to receive their passes by opening day. The application form is also available on the website along with additional information.

Applications will be approved by Capitol Property Management if the applicants are in good standing (i.e. no delinquent dues or violations). Capitol Property Management will notify ineligible applicants of their violations and procedures for correcting them. Our community renters will also need to provide a copy of their current lease agreement with the pool application as proof of PWCA residency. Passes will be delivered to the home in mid-May. Pool use is for residents and their guests only; you must have a valid 2013 pass to be admitted.

The social events for 2013 are currently being planned. The following is a current list of planned events:

- May 25 Opening Day. Hot dogs and lemonade starting at Noon.
- June 9 "Sundaes on a Sunday." Make your own sundae 3 PM. until 4 PM.
- July 4 Annual July 4th barbecue, hosted by your PWCA HOA, starts with hot dogs grilling at Noon, BBQ buffet at 1 PM, games at 2 PM. This is a big neighborhood project, so we need volunteers to help organize the children's games and contests and bake desserts.

In addition to the listed festivities, we plan to host a pasta party and Mexican Fiesta during the summer. The season will end on Labor Day weekend with our fourth annual Chili cook-off. Dates and times are TBD and more information will be posted on the pool house bulletin board. Volunteers are always needed to help plan other social events. Please contact Joan or Joanne if you have any suggestions and/or want to plan an activity.

A section of the pool deck can be reserved for a small party. Team, birthday, or any small gathering can be scheduled by reserving the date and time with a pool chair person. The lifeguards will make tables, grill and refrigerator available if needed. Guest passes are required for all non-residents attending. Additional guest passes can be purchased by calling Joanne or Joan. Clean-up is the responsibility of the host resident.
