

#### **PWCA Permit Parking Program**

Several issues and questions have arisen in the past several months regarding the PWCA permit parking program, which prompt us to recap some of the PWCA parking rules, as follows:

**ALL** vehicles parking in the community **MUST** have either a resident or guest permit (including, but not limited to, all vehicles parked in assigned spaces).

Any new owners, landlords with new/ renewed leases, or residents with new



Renter's permits are issued only for the period of the lease, and the month and vear of the termination of the renter's lease period will be indicated on the permits.

All owners requesting any new permits must submit applications/requests at least fifteen days prior to the issuance of new permits, and permits normally will be issued within seven days of the application's receipt.

No owner shall request a resident permit for anyone not actively residing within the community.

If a resident loses a permit, the resident must pay an administrative replacement fee, and the old permit will be immediately revoked. If a second permit is lost, the resident must petition the PWCA Board to receive a further replacement.

Visitor permits are to be strictly used by visitors to a resident's home and are to be returned to the resident when the visitor leaves. They are not to be regularly used by individuals not normally residing at the permitted address, or loaned to others to use while not visiting a residence.

No person shall use a parking permit which has not been issued by PWCA (i.e., duplicate, or "counterfeit" permit), or otherwise park a vehicle not authorized in PWCA areas.

Misuse of parking or guest permits can result in sanctions, including confiscation of the pass and the loss of parking privileges.

Temporary guest permits are available, can be requested between 9 a.m. and 9 p.m., and a list of PWCA parking officials can be found at <u>www.parkwestcommunity.org</u>. Please request temporary permits as early as possible (i.e., at least 2 hours prior to need, if possible), especially with requests for larger numbers of guests.

#### PUMPKIN GINGERBREAD

"Wonderfully flavorful and fragrant bread for the holidays."

Original recipe makes 2 - 9x5 inch loaves

- 3 cups sugar
- 1 cup vegetable oil
- 4 eggs
- 2/3 cup water
- 1 (15 ounce) can pumpkin puree
- 2 teaspoons ground ginger
- 1 teaspoon ground allspice
- 1 teaspoon ground cinnamon
- 1 teaspoon ground cloves
- 3 1/2 cups all-purpose flour
- 2 teaspoons baking soda
- 1 1/2 teaspoons salt
- 1/2 teaspoon baking powder



#### Directions

- 1. Preheat oven to 350 degrees F (175 degrees C). Lightly grease two 9x5 inch loaf pans.
- 2. In a large mixing, combine sugar, oil and eggs; beat until smooth. Add water and beat until well blended. Stir in pumpkin, ginger, allspice cinnamon, and clove.
- 3. In medium bowl, combine flour, soda, salt, and baking powder. Add dry ingredients to pumpkin mixture and blend just until all ingredients are mixed. Divide batter between prepared pans.
- 4. Bake in preheated oven until toothpick comes out clean, about 1 hour.

### Want to improve your curb appeal?

If your front steps and stoops are stained, worn or dull, try this! Cleaning can be accomplished with products such as Clorox Outdoor Bleach Cleaner. This can clean and help remove stains. Once the steps are pressure washed, allow 48 hours for them to dry, and then you can apply a concrete sealer to protect your investment. Apply 2 coats to ensure 100% coverage of your stoop and stairs. Alternatively, hire a contractor. You may discount your costs when your neighbors share the same contractor. If you

#### **PWCA Architectural Modifications**

Exterior alteration or modification of a Kings Park West Community townhome (including window replacement) is not permitted without prior written approval from the Architectural Control Committee (ACC). Requests should be made via the Architectural Control Modification Form found on the PWCA website. The completed form should be mailed to PWCA Architectural Control Committee, Attn: ACC Chair, c/o Capitol Property Management, 3914 Centreville Road, Suite 300, Chantilly, Virginia 20151.



Have you been visited by solicitors lately? Many residents have and they have called the HOA asking for help. Please know that a "No Soliciting" sign is prominently displayed at both entrances to the neighborhood. However, solicitors with permits can

walk right past it, and ring your doorbell-LEGALLY!

Soliciting is the sale of goods or services door-to-door or from a temporary stand and is regulated by Fairfax County Code. Fairfax County requires peddlers and solicitors be licensed before they solicit door to door. They may solicit only between 9 a.m. and 8 p.m., and may not solicit at a residence which posts a "No Peddlers or Solicitors" sign. So, if you want to avoid an untimely or unwanted knock on the door...buy a small sign and post it on your front door.

A peddler or solicitor must show the license upon request and must leave the premises immediately if asked to leave. Often solicitors will show customers an ID badge or some other document, claiming that they are licensed by Fairfax County when they are not. When a solicitor knocks...

- Ask for his or her license.
- If they do not have a valid license, ask them to leave.
- Close and lock your door.
- Immediately call Fairfax County Police (non-emergency) at 703-691-2131 to report the violation.

# Respecting

Do you or your children walk your dogs in other peoples' yards? Do your kids play so that soccer balls or baseballs hit others' homes or parked cars? Do you throw loud parties late into the night? These are frequent



concerns for neighbors and can lead to awkward or hostile feelings and disrupt the harmony of our community.

Unfortunately, these issues are occurring within our PWCA community. Your HOA cannot regulate or settle neighbor-to-neighbor disputes or private property trespassing issues. Please be aware that residents are well within their rights to report trespassing or property damage to the Fairfax County Police. Let's all be good neighbors and respect the property of others! Thank you.

## **The University Mall--Construction Update**

- •The long-awaited \$30 million renovation of the aging University Mall began in May, and its new identity will take shape as new stores crop up over the next several months. The mall was built in the mid-70s and has already seen transformation. The old cedar shade canopies have been removed, and all traces of brick will be replaced by honey-colored cut-face concrete blocks (that look like granite).
- The concrete slab has been poured and Wendy's will start building next month. It takes three months to build a Wendy's from the ground up and the fast-food joint is expected to open in November.
- •The concrete slab is being poured next Tuesday, and the local Cardinal Bank branch is expected to open next spring.
- •The Giant (grocery) is scheduled to close in January 2014. It will take seven months to finish the expansion, move the retail area to a 51,000 square-foot second floor and build large indoor loading area to keep large grocery trucks hidden from public view.



- The southern section of storefronts are expected to be finished within the next month and the northern storefronts by the end of September. The courtyard will feature fountains, new trees and wireless Internet.
- •Traffic and parking remains a problem at the shopping center. George Mason University widened Braddock Rd. near the mall and the intersection of the entrance into the mall has longer left turn lanes, crosswalks and dual lanes that feed into the university. Next year, the county will redo the intersection of Ox and Braddock Roads, resulting in dual left lanes in every direction.

#### PWCA ANNUAL MEETING ANNOUNCEMENT

The HOA's annual community meeting will be convened on November 21st in the Robinson HS Gold Cafeteria, at 8pm. The HOA will hold Board elections for three seats, vote on any changes to our Covenants and present the 2014 budget. We must have at least 10% (27) of our property owners present or proxy. Look for a future announcement or mailer regarding nominations and issues of concern. This is the time to offer your suggestions to improve our community, join a committee, or otherwise sound off. # SCHOOL BUS STOP ETIQUETTE

Do your kids wait at a school bus stop in the neighborhood? Now is a great time to remind everyone of bus stop safety and etiquette pointers.



#### SAFETY:

- Look both ways before crossing the street
- Never exit the bus without looking for traffic
- Don't stand in the road--stand safely on the curb ETIQUETTE:
- Do not litter! The neighbors whose yards you're throwing the juice boxes into should not have to pick up after you.
- Don't roughhouse! Chasing kids or running into the street can be dangerous! Stay out of the street until the bus arrives.
- SHHH...be courteous and quiet. Being loud or using foul language can disturb the neighbors.

### **STREETS and SIDEWALKS**

Work completed this year:

- Patched street at the intersection of Gainsborough Dr. and Treasure Ct.
- The sidewalk bridge near tot lot was repaired and new a new water drainage system under bridge was installed.
- Two stop sign posts were repaired and re-installed due to vandalism.
- Removed and repaired sections of path from Pool to the Bridge, then installed a new sealcoat.
- Installed asphalt overlay on path from Bridge to the concrete path that goes to the tot lot.

Future/planned improvements or repairs:

- Street repainting at intersections near stop signs.
- Curb repainting for (yellow) no parking areas
- Speed bump repair and repainting
